# "Meeting the climate challenge: New legal instruments and issues in national and international energy and climate law"

## **Project report 2008**

### 1. Project presentation

The project "Meeting the climate challenge: New legal instruments and issues in national and international energy and climate law" started in September 2006. The project is an activity of the Natural Resources Law Group at the Faculty of Law, University of Oslo. It is funded by the interdisciplinary research programme on climate and renewable energy (RENERGI) of the Research Council of Norway. The project leaders are professor Ulf Hammer (energy law) and professor Hans Chr. Bugge (environmental law - research group leader).

The principal objective of the project is to develop and maintain, at the Faculty of Law, a robust research group in the dynamic and intersecting fields of national and international energy and climate law. The group shall follow closely, and if possible contribute to, the further development of climate and energy law, and collaborate with national actors and recognized international partners and networks.

Its main elements are two interrelated studies at PhD/post-doc. level: The *PhD* study shall provide insight in the complex interface between climate and energy related legislation in international and EU law. In particular, it shall analyze the various new legal mechanisms to promote renewable energy, develop energy savings measures and reduce GHG emissions, and the relationship between them. The *post doc.* study – or studies - shall analyze certain legal aspects of the Clean Development Mechanism under the Kyoto Protocol, in particular environmental safeguards in the perspective of environmental integrity. It shall follow the further implementation and development of the CDM and discuss its potential as a post-Kyoto instrument.

In addition, several *master students* are linked to the project. They write master theses on relevant topics

The project has two formal *national partners* which contribute funding: Enova SF and Norway's Pollution Control Authority (SFT), and *four international partners*: Pace Law School (Energy project, Richard Ottinger), and Centre for International Sustainable Development Law, Montreal (Marie-Claire Cordonier Segger), University of Bremen (Gerd Winter), and Katholieke Universiteit Leuven (Kurt Deketelaere).

### 2. Project activities.

The project organized two all-day seminars in Oslo:

- "Legal issues related to Carbon Capture and Storage (CCS)" with national and international participation, on 8 February.
- "Kvotehandel og karbonmarked et nytt rettsområde i utvikling" ("Emissions trading and the "carbon market" a new and rapidly evolving field of law") with national participants, on 28 May.

The PhD-student, *Catherine Banet* continued working on her project "*Promoting sustainable energy by market-based instruments: design and trading rules for certificates used to promote renewable energy, increase energy efficiency and reduce greenhouse gases emissions.*" During 2008, she published 2 book chapters and contributed with presentations at 4 major international conferences and several national events. She was on maternity leave from August to December.

Dr. juris *Christina Voigt* started her post doc. project "*Safeguarding the Environmental Integrity of the Present and Future Climate Regime - the Example of CDM*" in January. She edited a book together with Hans Christian Bugge, published 4 international book chapters/articles and gave presentations at 9 major international meetings.

Research assistant Froukje Maria Platjouw completed her master thesis "Reducing greenhouse gas emissions at home or abroad? A study on the Supplementarity Requirement for the Flexibility Mechanisms of the Kyoto protocol."

Research assistand *Sindre Løvgaard* completed his master thesis (in Norwegian) on regulating off shore wind power installations in international and Norwegian law.

Research assistant *Nina K. Hallenstvedt* completed her master thesis (in Norwegian) on the framework for state aid to carbon capture and storage projects in light of the EC/EEA state aids rules.

Research assistand *Eivind Junker* started work on his master thesis (in Norwegian) on *Climate – a national good, a free resource, or common heritage? An analysis of different regimes for regulating greenhouse gas emissions.* 

The group contributed actively to establish an interdisciplinary research and teaching programme at the University of Oslo entitled *Environmental Change and Sustainable Energy*. Hans Chr. Bugge is member of its executive board and Christina Voigt is member of its scientific panel.
